SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The district has surveyed parents, coordinated strategic planning across all grade levels and content areas at the elementary and secondary levels, and considered the academic, social, and emotional initiatives already underway as we designed a meaningful plan for the application of these funds. The resulting plan serves to assess impact of loss of instruction to frame student needs, support the specific needs of our classified students and low income students, support families, and maintain facilities with repairs and minor improvements.

The following initiatives were generated from stakeholder input- including teacher input, student assessment data, support staff input, administrator input, and facilities staff:

1. Focus funding on early childhood programming- funding will be used for a three year period to fund salaries and benefits of two (2) pre-K teachers and two (2) teaching assistants
2. Focus on the social/emotional and mental health of students- Funding to be used for three years to support salaries of two (2) social workers and psychologist services, a sensory walk, and t-shirts for all students and staff.
3. Focus on facility enhancement and health and safety repairs- Funding will be used to replace unventilators in the secondary school, upgrade auditorium sound systems for enhanced CTE learning opportunities, purchase cafeteria tables to accommodate social distancing in lunch sitting, and repair the fueling station at our transportation facility.

The District will review plans and implementation on a continual basis by consulting with teachers, support staff, facilities staff, and any other stakeholders responsible for implementation on a regular basis, generally every six months through September, 2024. Feedback from the stakeholders will be used to adjust expenditures based on any changes which may occur over time. Finally, in each six month cycle, the District will make a public presentation at a public Board meeting to reflect the expenditure and any shift going forward. 3. **In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

For the 2021-22, 22-23, and 23-24 school years we will fund additional psychological services, social worker services, and counselor services with the aim of closing initially observed learning gaps in math, reading, and social/emotional skills. We then hope to be able to move beyond responding to mental health crisis' related to prior school closure and parallel social isolation to proactive training and instruction meant to cultivate social skills to adapt to uncertain situations with resilience and confidence that comes from being connected to a strong school community. Academically, ARP funding will be used to support instructional costs for our Pre-K program, including professional teacher salaries and support staff salaries. This will ensure that our youngest learners will have the necessary skills and experiences to enter Kindergarten.

Parallel to the social/emotional and academic efforts, we will enhance the sound system in our auditorium to allow for improved student opportunities as engage in theater and the arts. We see these activities as key complimentary student activities that improve content knowledge and skill development. Other equipment and minor facility improvements through the use of ARP funding includes a project to replace univentilators in our secondary school. The modernized units will create improved air exchange between indoor air and outdoor air, mitigating the potential spread of the COVID-19 virus, preventing the spread of the COVID virus. Additionally, ARP funds will be applied to repair maintenance of brick and concrete areas surrounding entry ways at the elementary school, creating a more healthy and safe campus. The deteriorating and crumbling areas present a hazard and create an unsafe condition for students, staff, and visitors to the building. Finally, a fuel pump control system will be purchased and installed as a last component of a project to replace our bus fueling station at our transportation facility, allowing us to operate our fleet at maximum levels to minimize the potential spread of the virus on buses.

In 2020-21, the District secured a new formative assessment program through iReady. As an online platform for delivering content, support, and assessment, the resources have been valuable in our efforts to vertically align our curricula in Math, ELA, Social Studies, and Science. The online platform allows us to easily assess students three times per year, giving us timely data on both mastery and student growth. Being in-person for the entire 2020-21 school year was a benefit for our students. The iReady data indicated the average growth for a student over the course of the school year was 135%.

Using individual student data, teachers determine specific skill-based or content-based needs and develop a targeted approach for each student based on their individual needs. The instructional support plans will be delivered in classroom settings, comprehensive afterschool programs, and in summer intervention programs, all of which are supported through ARP funding to one degree or another. Individual instructional support plans can be modified with each administration of the formative assessment program. iReady data will be used to evaluate the effectiveness of the in-person programs delivering the support to students and to make modifications to plans.

Our PK program can be evaluated using the iReady data as well. Additionally, data reports are generated from classroom instructional delivery and are used to establish interventions for students and modifications to program. The district consistently tracks student literacy growth by monitoring the progress of letter identification, letter sound articulation, blending sounds, and sight word mastery.

The district will track counselor, social worker, and psychologist interventions with students over mental health issues. Interventions and supports will be designed to de-escalate acute crisis and establish proactive strategies to cope with daily social/emotional challenges.

The 20% allocation in this section of the grant is consumed with Pre-K and social/emotional and mental health related needs, as well as facility enhancements to mitigate the spread of COVID-19. These funds will provide services to support literacy development in our pre-K program and counseling support to our K-6 population. Internal data shows that primary level students have returned to school with gaps in letter identification and skills for blending letter sounds, leading reading deficiencies. In terms of social /emotional and mental health needs, the District has seen significant increases in mental health issues due to the isolation from not begin in school on a regular basis. Counseling, social work, and psychological intervention will be aimed at stabilizing those issues across the entire student body.

The District will use ARP State Reserves to summer enrichment and comprehensive afterschool programs.

The LEA's general plan for use of ARP funding includes the following areas:

1. Supporting early childhood education by funding instruction and support services for Pre-K students
2. Addressing student mental health issues related to the pandemic, while also proactively building social emotional skills through psychological, counseling and social work in each of the three years of the grant funding
3. Facilities maintenance repair projects to ensure a healthy, productive, and safe environment inside and outside of school buildings, and while riding on district transportation
4. Cafeteria tables needed for appropriate distancing so students can eat in the cafeteria instead of in the classroom to help with social and emotional needs.
5. T-shirts for all staff and students to bring unity to the school after 18 months of separation as a school.
6. Sensory walk for Special Education Students who have sensory needs.
7. Enhance auditorium sound and microphones for drama club, band and choir concerts, along with other organizations in the community who will use the sound system in order to enhance social and emotional needs.

Our district serves two primary sub-groups- low income students and children with disabilities. We have a 38% FRPL rate and a 16% classified student rate. It is typical for these subgroups to have gaps in skill development in reading and math. The added pre-K and counseling/support staff will focus specifically on closing those reading, math, social/emotional gaps.

The LEA will review the implementation of the funding plan on a regular basis, no less that three times per year for the next three years.
