	1. Funding will be utilized to support professional salaries for a school counselor, social worker, and psychologist as a means to be responsive to the mental health and social/emotional needs of students due to the pandemic. 50,000 x 3 positions x 2 years = \$300,000
	2. Funding in the category will also be used to fund a position assigned to establish a grades 5-12 College and Career Readiness program. 	Other expenses in this category include labor and materials cost for replacement of the fueling station at our transportation facility. The system is nearly thirty years old and near the end of the 2020-21 school year, the system failed. With several weeks remaining to transport students, the District was forced to replace the system. The replacement included removal of the failed system and existing underground fuel lines from storage tanks to the location of the fueling station, installing a new fuel pump, new underground fuel lines, and wiring necessary for proper operation. Replacement was necessary for continued uninterrupted transportation service for students. Transportation of students in a rural community is critical to their access to public education, leading to their healthy social, emotional, and academic development. We expect
